MARK YOUR CALENDAR FOR MEETING: MONDAY, NOVEMBER 28

As in the last two years, The NYS League will create a Legislative Agenda booklet with a short description of many of the issues the League anticipates working on during the next legislative session; the booklet will be available to all local Leagues in January. It is essential for the State League to hear from the local Leagues and individual members what issues are most important to them. The responses ensure that the State League's legislative activities will be in line with the concerns of its membership.

The Tompkins County League has scheduled a meeting of the full membership for Monday evening, November 28, at 7:00 PM at Kendal at Ithaca in Conference Rom A. This meeting will be devoted to a discussion of the important issues in our community which we feel deserving of inclusion in the legislative agenda at the state level.

NATURAL RESOURCES

The Natural Resources Committee will present a program Roads to Our Energy Future on Monday, November 14, at 7p.m. in the Borg Warner Room of the Tompkins County Library. Our speakers will be Katie Borgella, Deputy Commissioner of Planning for Tompkins County, and Jonathan Comstock, a leader in developing the *Heat Smart Program* for 2016-2017. We expect it to be an interesting program, targeted at helping the general public become familiar with the Tompkins County Energy Roadmap, the Heat Smart Program, and other important energy related activities going on in the county. We are already getting responses that indicate residents are interested in a deeper discussion than we will be able to present during this program, so we will be gathering information from those in attendance for use in developing a follow-up program.

The committee plans to spend the coming year learning about local housing needs and the impacts that needed development may have on both land and energy use. The county is holding a housing summit November 30 and December 1, which a few of us plan to attend. The summit will be looking at general housing needs, the need for affordable housing, and ways to ensure that development will be done in ways that are good for the environment. The county website has posted a schedule for the summit at housingtompkins.com/, along with other inforation about the summit.
