A note from Kay Sharp, League President

We have been very busy with several voter registration events. We were at the Farmer's Market, National Voter Registration Day and, most recently, the Apple Harvest Festival. Thank you to those who volunteered for these events. Without you we would not have been able to offer this important service for our community.

At the voter registration events, we got the names and contact information from 13 people who are interested in knowing more about our League. Alene Wyatt, Lori Saltzman and I are going to contact each of them and ask them to join. It would be great if they all became members.

In addition to voter registration, we participated in two candidate forums. We still have one more later this month. It is always rewarding to engage in these events. We were contacted by two other districts, but they decided to not co-sponsor with us. The reason they gave was "the League is too liberal". This response was discussed with the candidates, and I stressed that we are a non-partisan organization and believe that we can conduct ourselves accordingly.

We are participating in VOTE411, an electronic voter guide, for the first time. Kathleen Yen is coordinating this project. Every candidate who is running for election in some position in Tompkins County was contacted and asked to provide information about their interest and experience that they believe makes them the best candidate for the position. All of their responses are then placed on line in a voter's guide, which the community can access through our website. So far, Kathleen has received 50% of the candidates' responses. We are excited about offering our community a snapshot of

candidates before they go to the voting booth. Thank you so much Kathleen for working on this important community resource.

I am sad to say that one of our Directors for Voter Service, Amy Panek, has resigned due to personal reasons. She has worked in this capacity for three years. I hope Amy will continue to be a member; she has much to offer us. It would be nice if one of you would volunteer to complete her term, which is over in May 2017. The Board would appreciate your help. Please contact me if you are willing.

I hope you attended our program on the Constitutional Convention. It was very informative. It was a great success, over 90 people attended. This is a record for our League, at least in the ten years that I have served. Thank you goes to our VP for Programs Charlotte Coffman for organizing and moderating this event. Our program for October promises to draw a large crowd as well. See Program Report.

In addition, we are co-sponsoring two programs offered by the Tompkins County History Center. One is on voting experiences and the other one is on women in public service. See Program Report for details.

There are two concurrence proposals this year. One is on amending our position on charter schools and the other is on "Death with Dignity". We are planning a program in January to examine the issue of assisted-death. There are five states who currently have laws that allow for physician-assisted deaths, they are Oregon, Washington, Montana, Vermont and California. Our study materials are provided by the Utah State League.



After the program in January, we will hold a meeting to decide on our position on these two proposals. Our feedback to the State League is due February 15, 2018.

Last, but certainly not least, we have two new Cornell student liaisons who just joined the Board this month. Jack and Liel will help with the Students Inside Albany project. It is wonderful to have young people on the Board; they offer a distinctly different view on our business. Welcome to the League!

A note from Kay Wagner, Natural Resources

The Natural Resources Committee is continuing to discuss the issue of Tompkins County housing needs and how to solve those needs in ways that are good for the environment and promote thoughtful use of land. Many new construction projects are currently underway, especially in the City of Ithaca. Some of the projects are making use of heat pumps and are being built with other environmental issues in mind. Others are simply being built to code and will increase our dependence on natural gas. In our September bulletin we mentioned that Taitem Engineering has done a study indicating that the use of heat pumps can make economic sense for developers, so it is good to see that some of the developers doing local projects are understanding the benefits to be gained by making use of this technology.

Some of us had a chance to go to the electric car expo that was held near Press Alley in September. Local electric car owners brought their own cars and talked to people about them. Some even offered rides. One of our members had a chance to ride in a four year old Tesla and enjoyed not only the ride but also learning a lot

more about what it is like to own and drive one. There is likely to be a similar event next fall and we are looking forward to attending it.

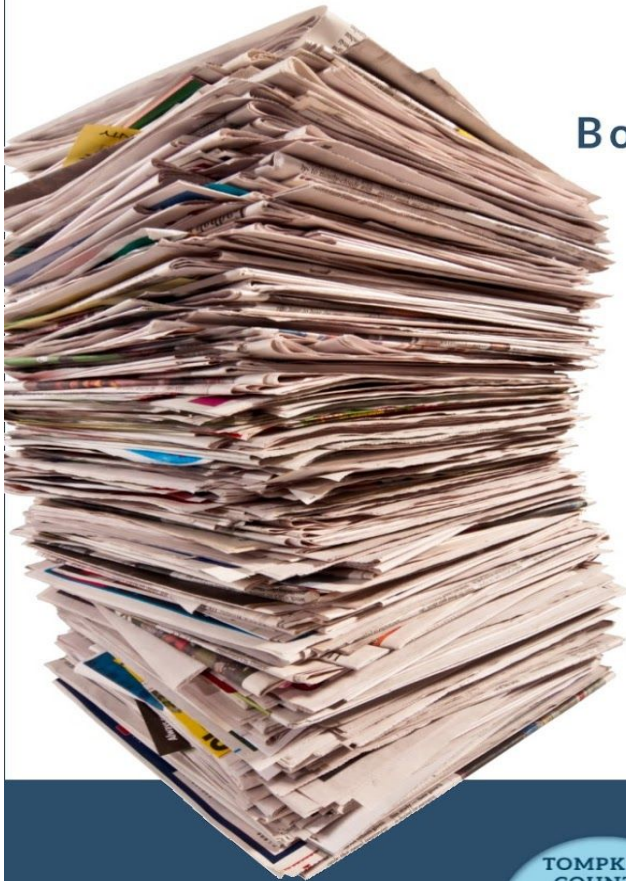
The recent hurricanes that hit Texas, Florida and the Caribbean are not only reminders of the effects of climate change, they have also pointed out the fragility of much of our electrical grid and the effect of storing toxic chemicals in areas prone to flooding. Puerto Rico's electrical grid was almost totally destroyed. There is now some discussion (including proposals by Elon Musk) of the possibility of rebuilding the island's power grid with solar power. It could provide a real opportunity to do a complex experiment that looks to the future, but it is likely to only be possible if government assistance is provided.

Our committee is currently planning a program for February. We hope to address the issue of the local need for affordable housing and how to address these needs in environmentally healthy ways. We are also in the process of compiling a list of interesting books that focus on environmental issues. We plan to post the list on the LWVTompkins website, giving a short description of each book. If you have any suggestions of books to include please send them to Kay Wagner and include a couple sentences of description. In keeping with the League's commitment to remaining unbiased with regard to political parties and candidates, please keep our non-partisan stance in mind when suggesting books.

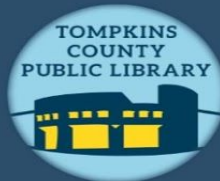

A note from Programs, by Charlotte Coffman, VP for Programs

The program committee met on September 13 and, in addition to planning the upcoming programs, agreed to implement four program-related strategies:

-Experiment with ways to tape our programs and post those recordings on our website. Ann Warde recorded the September meeting using her laptop; videographer Jim Blizzard will tape the October meeting; and Megan Nettleton will use a GoPro video camera during the November meeting. The board can then compare the results and the cost of the three methods, as well as evaluate whether the posted videos are actually viewed.

-Invite the program audience to consider League membership. We will have membership forms, informational brochures, and a friendly face to answer questions at the upcoming events. We will try this for the fall programs.

-Work harder to obtain co-sponsors and strive to be more active co-sponsors ourselves. This has always been a League goal and the study groups have excelled at bringing in community partners. We just want to extend their good practice to our other programs.

-Train more members to use the Library audio-visual equipment. On September 22, Megan Nettleton and Charlotte Coffman were trained by Library staff – and we are willing to train others!

A SEPTEMBER SUCCESS

Our September program, The Constitutional Convention Debate, attracted over 90 attendees who asked thoughtful questions and even carried a few signs signaling their views. We are grateful to Dr. Henrik Dullea, Vice President for Community Relations Emeritus, Cornell University and NYS Assembly Representative Barbara Lifton for their careful preparation, clear explanations and willingness to give of their time. The League of Women Voter of Tompkins County is pleased to announce the launch of Vote411.org, an electronic voter guide, for the November 7, 2017 county, town, and city races in the General Election.

The three New York state ballot proposals that will appear on the ballot, and the City of Ithaca proposition that voters in the City of Ithaca will be asked to vote on are included. Candidate information, supplied by the candidates, includes biographical information and responses to questions posed by the League. Candidates who did not submit their information are listed with "Candidate Has Not Responded". Other election and voting information is also provided.

A six-page PDF, "2017 Local Voter Guide for Tompkins County Voters: Offices, Candidates, and Ballot Proposals" is posted on the League website. It is also included in the n the [Vote411](http://Vote411.org) electronic guide. It summarizes who and what Tompkins County voters will be asked to vote on in the 2017 General Election and includes: candidate for State Supreme Court Justice, 6th J.D.; candidates for the 2017 county, city, and town offices to be filled in Tompkins County;

and how the ballot proposal questions will appear on the ballot.
